As a participant ("Participant(s)") in the 4th Winter Youth Olympic Games 2024 in Gangwon, Republic of Korea (the "Games"), I agree that my participation in the Games is subject to me accepting, and complying with, these Conditions of Participation (including their Annex I "Information Notice on the Processing of Personal Data of Participants and other Accredited Persons" and the different rules referred to below, together the "Conditions of Participation"), which have been determined by the International Olympic Committee (the "IOC") and the Gangwon 2024 Winter Youth Olympic Games Organising Committee ("Gangwon 2024").

I understand that in case I am a minor or without legal capacity under the laws applicable in my country of residence at the time of signing this Conditions of Participation form, my participation in the Games is also subject to my parents or legal guardian(s) authorising my participation and confirming their agreement with the rules below through their signature of the Parent/Legal Guardian Acknowledgement of Consent form.

1. Compliance with the Olympic Charter and other rules. My participation in the Games is subject to me complying with certain fundamental rules which aim at ensuring the integrity of the Games, protecting the health of the Participants and protecting clean athletes.

I confirm being aware of and know the rules and responsibilities applicable to my participation in the Games, which have been brought to my attention by my National Olympic Committee ("NOC"), the International Federation ("IF") governing my sport, Gangwon 2024 and/or the IOC, among others through the IOC's official website: www.olympics.com. I agree to comply with all these rules and responsibilities in particular those arising from the following texts:

- a. the provisions of the Olympic Charter;
- b. the World Anti-Doping Code, as well as the IOC Anti-Doping Rules applicable to the Games and any related regulations, such as the IOC Needle Policy & Rules;
- c. the IOC Code of Ethics, including, in particular, the Rules on the Prevention of the Manipulation of Competitions applicable to the Games:
- d. the IOC Youth Olympic Games Framework for Safeguarding Athletes and Other Participants from Harassment and Abuse in Sport (Games time Period);
- e. the IOC Social and Digital Media Guidelines; and
- f. any set of rules and instructions (including any update thereof) related to my participation to the Games.
- 2. Capture and use of images. As a Participant, I may be filmed, photographed, identified and/or otherwise recorded at the occasion of the Games. Images of me taken at this occasion may be used together with related information as part of the media coverage of the Games, or otherwise to inform the public about the Games and promote the Olympic Movement.

I understand that the Games are an exceptional and public event which has ongoing international and historical significance. In consideration of the acceptance of my participation in the Games, I agree to be filmed, photographed, identified and/or otherwise recorded during the Games. I further agree that the resulting filmed, photographed or recorded image (together with my name, likeness, voice, performance and biographical information) may be used and/or distributed (including by reproducing, distributing, communicating to the public and making it available), in any content and through any media, format or technology whether now existing or created in the future, without payment, for the maximum duration permitted by applicable law, by Gangwon 2024, the IOC and any entity or company now existing or to be created, which is directly or indirectly controlled by the IOC (such as The Olympic Foundation for Culture and Heritage, IOC Television & Marketing Services SA, Olympic Channel Services SA and Olympic Broadcasting Services SA) and their affiliates ("IOC's Affiliates") and/or by third parties authorised by them (such as Organising Committees for the Olympic Games or the Youth Olympic Games, National Olympic Committees, International Sports Federations, the Olympic Marketing Partners (TOP Partners and Media Rights Holders), domestic partners and other commercial partners, broadcasters, media rights holders, news media organisations or social media platforms), during and after the Games, for the maximum duration permitted by applicable law, in relation to the preparation, operation, celebration and direct or indirect promotion of, or reference to, the Olympic Games, the Olympic Movement and/or the IOC and its activities, in a commercial or non-commercial context, but excluding any use that creates a direct commercial association between my image alone and any product or service of any third party, without my separate written consent.

I acknowledge that I may take or record still and moving images and/or sounds within the perimeter of the Games' areas and venues where the Games and related events occur, as designated by Gangwon 2024, including their surroundings ("Games Areas") for my personal, private, non-commercial and non-promotional use, subject to compliance with the IOC Social and Digital Media Guidelines, and I agree that the IOC shall be sole owner of any intellectual property rights (including copyright) in such content without further authorisation from, or payment or compensation to, me or anyone acting on my behalf, and I hereby assign any rights I may have in respect of such content to the IOC. To the extent permitted by applicable laws, I hereby agree to waive or not to exercise any moral rights I may have in respect of such content against Gangwon 2024, the IOC and any third parties authorised by them, including without limitation the right to make derivative works.

Pursuant to the above, I acknowledge that the IOC hereby grants me with a limited and revocable license to use the still and moving images and/or sounds that I take or record within the Games Areas, provided that such use is personal, private, non-commercial and non-promotional and that otherwise complies with any additional IOC requirements (including the IOC Social and Digital Media Guidelines). I acknowledge that I am solely responsible for the use of these still and moving images and thereafter, I release Gangwon

2024, the IOC, and the IOC's Affiliates, as well as any third parties authorised by them (and their respective members, directors, officers, employees, volunteers, contractors or agents) (collectively, "Released Parties") from any responsibility in connection with them. I understand that, in case of breach of the IOC Social and Digital Media Guidelines and/or any other rules or guidelines regarding the recording or making available of content, the IOC shall be entitled to take any action in order to remedy such infringement.

I acknowledge that I am prohibited from: (i) taking pictures and videos and from recording audio or making any other recordings in any "Photography Prohibited Area" designated in the Games Areas and its surrounding areas, as well as in any other restricted areas designated by Gangwon 2024, the IOC or any other authorised person; and (ii) collecting, disseminating, transmitting, or publishing any scores, statistics or other information related to the Games taking place within the Games Areas for any commercial, betting or gambling purpose.

3. Sport competition including music and other creative elements as part of performance. My performance may include music and other creative elements (such us a choreography or a designed outfit) for which I acknowledge that the use of these elements may require third-parties' consent.

I confirm that I have obtained all rights and authorisations in connection with any creative elements included in my performance for them to be filmed, televised, photographed, identified and/or otherwise recorded as part of my performance at the Games, without any restriction or required payment, compensation or authorisation for Gangwon 2024, the IOC, the IOC's Affiliates, for their use in accordance with the terms described under Section (2) hereabove. In particular with respect to music (musical compositions and sound recordings), I confirm that, when obtaining or commissioning it, I have obtained all required authorisations and consents, in particular, in regard to its editing and adaptation to my performance for its use in accordance with the terms of this provision. I agree that I will report on the musical compositions and sound recordings used, in accordance with the processes and guidelines put in place by Gangwon 2024 in this respect.

4. Acknowledgment and acceptance of risks while participating at the Games. My participation to the Games may imply exposure to certain risks (e.g. injury, loss of property, infectious diseases), which despite all care taken by Gangwon 2024 and the IOC may not be eliminated.

I agree that I participate in the Games at my own risk and own responsibility, including any potential impact on my participation to and/or performance in the Games, serious bodily injury or potential exposure to health hazards such as the transmission of infectious diseases while attending the Games (including the travel to/from the Games and its preparations). I will take all reasonable measures to protect myself from the risks related to my participation and to mitigate the risk of such exposure. I also agree that I am responsible for all property I bring into the Games sites and that the Released Parties shall have no responsibility for any loss or damage to this property.

To the fullest extent admissible under applicable laws, (i) I irrevocably release the Released Parties from any liability for any kind of loss, injury, infectious disease or damage that I, or my property may suffer or be exposed to in relation to my participation in the Games and (ii) notwithstanding the foregoing, in any event where the Released Parties are liable for any damages I suffered under the applicable laws, I agree that the Released Parties' liability shall be limited to actual and direct damages which are reasonably incurred by me.

5. Processing of Personal Data. Gangwon 2024, the IOC and relevant third parties involved in the staging or coverage of the Games will process certain personally identifiable information about me to allow my participation to the Games, ensure the security at the Games, manage accreditations, competitions and results, carry out the anti-doping activities, prevent manipulations of competitions and provide services to Participants and to the media.

I confirm that I have read and understood the "Information Notice on the Processing of Personal Data of Participants and other Accredited Persons" (as reproduced in Annex 1 to these Conditions of Participation and referred to as the "Information Notice") which contains important information regarding the processing of Personal Data (as defined in the Information Notice) relating to Participants, the purposes of such processing, the collection of Personal Data, including Sensitive Personal Data and Unique Identification Data (as described in Section 5 of the Information Notice) and data transfers to third parties. I further acknowledge that complementary information regarding the processing of my Personal Data may be provided to me in due time and I agree to read carefully such complementary information.

In particular, I agree that my Personal Data, including but not limited to <u>Sensitive Personal Data and Unique Identification</u> <u>Data (as described in Section 5 of the Information Notice)</u>, will be processed in a manner consistent with the Information Notice and that some of my Personal Data will be subsequently transferred from Gangwon 2024 to <u>the IOC and/or other recipients set forth in Section 6 of the Information Notice</u> including those located outside of the Republic of Korea (note: insofar as EU General Data Protection Regulation 2016/679 and/or the Swiss Federal Act on Data Protection may also apply to the Processing of Personal Data contemplated in the Information *Notice, in particular vis-à-vis Participants coming from a member State of the European Union, the applicable legal grounds for such processing are those described in Section 7 of the Information Notice)*. 6. Arbitration. The Court of Arbitration for Sport is exclusively competent to finally settle all disputes arising in connection with my participation in the Games

Unless otherwise agreed in writing by the IOC, any dispute or claim arising in connection with my participation at the Games, not resolved after exhaustion of the legal remedies established by my NOC, the International Federation governing my sport, Gangwon 2024 and the IOC, shall be submitted exclusively to the Court of Arbitration for Sport ("CAS") for final and binding arbitration in accordance with the Arbitration Rules for the Olympic Games, and the Code of Sports-related Arbitration.

The seat of arbitration shall be in Lausanne, Switzerland and the language of the proceedings English. The decisions of the CAS shall be final, binding and non-appealable, subject to the action to set aside to the Swiss Federal Tribunal.

I hereby waive my right to bring any claim, arbitration or litigation, or seek any other form of relief, including request for provisional measures, in any other court or tribunal, unless otherwise agreed in writing by the IOC.

7. Governing law.

These Conditions of Participation shall be interpreted in accordance with Swiss law, without reference to its conflict of law rules.

The seat of arbitration shall be in Lausanne, Switzerland and the language of the proceedings English. The decisions of the CAS shall be final, binding and non-appealable, subject to the action to set aside to the Swiss Federal Tribunal.

7. Governing law

INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA OF PARTICIPANTS AND OTHER ACCREDITED PERSONS FOR THE 4th WINTER YOUTH OLYMPIC GAMES GANGWON 2024

IMPORTANT INFORMATION - PLEASE READ CAREFULLY

This document contains important information regarding the processing of Personal Data of participants and other persons requiring an Accreditation or Guest Pass for the 4th Winter Youth Olympic Games 2024 in Gangwon, Republic of Korea. It indicates the organisations responsible for processing Personal Data of Accredited Persons, the key purposes for which such data is processed, as well as the applicable modalities and conditions. This notice also explains how Accredited Persons can exercise their rights under applicable data protection laws. Personal Data of Accredited Persons will be used only as necessary to achieve the purposes set out in this Information Notice, which may vary according to each Accredited Person's function(s) at the 4th Winter Youth Olympic Games Gangwon 2024. For this reason, some provisions applicable to Participants may not apply to other Accredited Persons. If you are applying for an Accreditation or Guest Pass, please read this notice carefully and make sure you understand it.

1. Definitions

In this Information Notice, the following definitions apply:

- a. "4th Winter Youth Olympic Games Gangwon 2024" means the 4th Winter Youth Olympic Games in Gangwon, Republic of Korea, including all sport competitions, ceremonies, cultural events, torch relay and other activities organised by Gangwon 2024 and the IOC in connection thereto.
- b. "Accreditation" means the "Youth Olympic Accreditation Card" (YOAC) provided to Accredited Persons to identify that they are eligible to be present at the 4th Winter Youth Olympic Games Gangwon 2024. The YOAC functions as the official Olympic document granting the Accredited Persons the necessary access to perform a specific function during the 4th Winter Youth Olympic Games Gangwon 2024, and (for eligible categories) as an official travel document which together with the Accredited Person's passport authorises entry into the host country of the 4th Winter Youth Olympic Games Gangwon 2024.
- c. "Accredited Persons" means (i) all persons applying for, or being granted, the right to be accredited for the 4th Winter Youth Olympic Games Gangwon 2024 including, without limitation, Participants as well as employees, agents and contractors of National Olympic Committees, International Federations, Gangwon 2024, IOC, IOC's Affiliates, Media Rights Holders, broadcaster, media organisations and other entities listed in Section 6 and (ii) all persons applying for, or being granted a Guest Pass for a 4th Winter Youth Olympic Games Gangwon 2024 venue including, without limitation, Guest Passes for the Youth Olympic Village(s), International Broadcast Centre, Main Press Area, Olympic Family Hotel and competition venues, and Training Access Passes for training and competition venues.
- d. "Authorised Purposes" means the purposes referred to in Section 4 below.
- e. "Gangwon 2024" means the Gangwon 2024 Winter Youth Olympic Games Organising Committee.
- f. "Guest Pass" means the nominative cards that grant temporary visiting access to persons not accredited or whose accreditation does not permit automatic access to some controlled Olympic venues. This includes, without limitation, Guest Passes for the Youth Olympic Village(s), International Broadcast Centre, Main Press Area, Olympic Family Hotel and competition venues, and Training Access Passes for training and competition venues.
- g. "IOC" means the International Olympic Committee.
- h. "IOC's Affiliates" means any entity, now existing or to be created, which is directly or indirectly controlled by the IOC, including without limitation Olympic Broadcasting Services SA (Switzerland), Olympic Broadcasting Services S.L. (Spain), Olympic Channel Services S.L. (Spain), IOC Television & Marketing Services SA (Switzerland), the Olympic Foundation (Switzerland), The Olympic Foundation for Culture and Heritage (Switzerland), the International Olympic Truce Centre (Greece), the Olympic Refuge Foundation (Switzerland) and the Foundation for Universal Olympic Ethics (Switzerland).
- i. "Participants" means, for the purposes of this Information Notice, the athletes, coaches, Chef de Mission, team officials and other members of the National Olympic Committees and International Federations delegations attending the 4th Winter Youth Olympic Games Gangwon 2024.
- j. "Personal Data" means any information related to any identified or identifiable Accredited Persons, including Sensitive Personal Data and Unique Identification Data (as defined in Section 5 below).
- k. "Process" (and its derivatives) means any operation or set of operations which is performed on Personal Data or on sets of Personal Data, whether or not by automated means.

I. "Responsible Organisation" means any organisation seeking an Accreditation for its Accredited Persons, responsible for collecting and submitting to Gangwon 2024 certain Personal Data and other accreditation information on behalf of each Accredited Person who it requires an Accreditation.

2. Responsibility for the Processing of Personal Data

Personal Data of Accredited Persons will be Processed by Gangwon 2024 and the IOC for the purposes and in the manner described in this Information Notice. Where deemed necessary for the Authorised Purposes (e.g. in relation to Accredited Persons who are minors or without legal capacity under the laws of their country of residence), Gangwon 2024 and the IOC may also Process Personal Data which relate to Accredited Persons' parents, legal guardians or entourage. Accredited Persons are requested to inform these third parties about the contents of this Information Notice.

Without limiting their capacity to act jointly or separately as they deem in the best interests of the 4th Winter Youth Olympic Games Gangwon 2024, Gangwon 2024 and the IOC have allocated their respective responsibilities as follows: Gangwon 2024 is primarily responsible for Authorised Purposes described in Section 4 paragraphs a, b, c and d, and the IOC is primarily responsible for Authorised Purposes described in Section 4 paragraphs e, f, g and h.

Gangwon 2024 and the IOC reserve the right to supplement or modify the information contained in this document where they deem necessary for the success of the 4th Winter Youth Olympic Games Gangwon 2024. In case of any Processing of Personal Data of Accredited Persons not described in this Information Notice, Gangwon 2024 and the IOC will provide adequate information to the concerned Accredited Persons and ensure that such Processing is based on the required legal ground(s) in accordance with applicable laws, including, where applicable, the explicit consent of the Accredited Persons.

3. Collection of Personal Data of Accredited Persons

Personal Data of Accredited Persons is collected on different occasions as required for the preparation, promotion, presentation, operation or otherwise necessary for success of the 4th Winter Youth Olympic Games Gangwon 2024 and, in particular, when Accredited Persons:

- a. apply for an Accreditation or Guest Pass and complete the registration process to attend the 4th Winter Youth Olympic Games Gangwon 2024 through their Responsible Organisation;
- b. are provided services such as accommodation, transport, meals, assistance or healthcare;
- c. travel to and from the Republic of Korea for the purposes of the 4th Winter Youth Olympic Games Gangwon 2024;
- d. are photographed or filmed at the occasion of the 4th Winter Youth Olympic Games Gangwon 2024 or otherwise as part of the media coverage of the 4th Winter Youth Olympic Games Gangwon 2024;
- e. are involved in any disciplinary procedure related to a suspected or actual breach of the rules applicable to Accredited Persons or other legal procedure in connection with the 4th Winter Youth Olympic Games Gangwon 2024:
- f. are involved in a research project conducted at the occasion of the 4th Winter Youth Olympic Games Gangwon 2024;
- g. take part in any activity in connection with the 4th Winter Youth Olympic Games Gangwon 2024;
- h. are subject to the measures implemented by Gangwon 2024, the Korean authorities, the IOC and other stakeholders on the occasion of the 4th Winter Youth Olympic Games Gangwon 2024 to protect the health of all Accredited Persons and to ensure the safe staging of the 4th Winter Youth Olympic Games Gangwon 2024, in particular against risks of serious bodily injury or potential exposure of Accredited Persons to health hazards such as the transmission of infectious diseases while attending the 4th Winter Youth Olympic Games Gangwon 2024;
- i. qualify to compete at the 4th Winter Youth Olympic Games Gangwon 2024 (Participants only);
- j. compete at the 4th Winter Youth Olympic Games Gangwon 2024 (Participants only);
- k. are subject to anti-doping controls and procedures (Participants only).

As a general principle, Gangwon 2024 will receive Personal Data of Accredited Persons through the intermediary of the Responsible Organisations of the Accredited Persons. In addition, in certain circumstances, Gangwon 2024 may receive Personal Data of Accredited Persons from any third parties where such Personal Data is necessary for the Authorised Purposes set out in Section 4.

4. Authorised Purposes

Personal Data of Accredited Persons will be Processed by Gangwon 2024 and the IOC for the following Authorised Purposes:

a. allowing the Participants' participation in, and the management of, sport competitions and other activities and events organised at the occasion of 4th Winter Youth Olympic Games Gangwon 2024 (including cultural and educational activities) and more generally enabling Accredited Persons to fulfil their role and mission at the 4th Winter Youth Olympic Games Gangwon 2024, and preparing, participating, attending and operating the 4th Winter Youth Olympic Games Gangwon 2024. Key activities include: review of applications for and management of Accreditation and Guest Passes for the 4th Winter Youth Olympic Games Gangwon 2024 (including all related rights and entitlements), sports entries, qualification systems and verification that Accredited Persons fulfil admission requirements, Delegation Registration Process, planning and scheduling, display of

- information within 4th Winter Youth Olympic Games Gangwon 2024's venues for the presentation of the Participants;
- b. facilitating the travel to and from, and stay in, Republic of Korea for the purposes of the 4th Winter Youth Olympic Games Gangwon 2024 and providing services to improve the Accredited Persons' experience at the 4th Winter Youth Olympic Games Gangwon 2024. Key activities include: provision of travel services, accommodation and related services (at the Youth Olympic Village(s) or in other accommodation facilities, as applicable), transport, communications systems;
- c. ensuring the safety of Accredited Persons and the security of the 4th Winter Youth Olympic Games Gangwon 2024. *Key activities include: security risk assessments, background checks, access controls (including screening tests) and video surveillance at and around the 4th Winter Youth Olympic Games Gangwon 2024 venues and sites;*
- d. protecting the health and wellbeing of Accredited Persons. Key activities include: the provision of healthcare, insurance and medical services to Accredited Persons at the occasion of the 4th Winter Youth Olympic Games Gangwon 2024, the implementation of measures to protect against risks of serious bodily injury or potential exposure of Accredited Persons to health hazards such as the transmission of infectious diseases while attending the 4th Winter Youth Olympic Games Gangwon 2024, the monitoring and treatment of athlete injuries, illnesses, infectious diseases or any other health states at the 4th Winter Youth Olympic Games Gangwon 2024;
- e. protecting the integrity of the sport competitions of the 4th Winter Youth Olympic Games Gangwon 2024 and ensuring the compliance of activities occurring at the 4th Winter Youth Olympic Games Gangwon 2024 with the Olympic Charter and other rules applicable to Participants and, where applicable, other Accredited Persons. *Key activities include: anti-doping programme of the 4th Winter Youth Olympic Games Gangwon 2024 (including but not limited to investigation, search and/or preservation of evidence in relation to suspected breach of the World Anti-Doping Code and other related rules and regulations), prevention of manipulation of competitions and more generally the identification, investigation and prosecution of suspected or actual breaches of the IOC Code of Ethics (including, in particular the Rules on the Prevention of the Manipulation of Competitions applicable to the 4th Winter Youth Olympic Games Gangwon 2024) and other rules applicable to Participants (as detailed in section 1 of the Conditions of Participation form);*
- f. managing sport competitions results and keeping official records of and other relevant information about the 4th Winter Youth Olympic Games Gangwon 2024 and the Participants. Key activities include timing and scoring services, compilation, verification and publication of official sports results (including without limitation as part of the sports results and information database developed by the IOC and Olympic Channel Services S.L. in cooperation with other members of the Olympic Movement), development of statistics (such as to support future Olympic Games planning needs and optimisation processes), historical studies, scientific and other research projects (such as for the prevention of injuries and illnesses in sport) conducted during and after the 4th Winter Youth Olympic Games Gangwon 2024;
- g. preparing, promoting and operating the 4th Winter Youth Olympic Games Gangwon 2024, and ensuring the widest possible media coverage and their legacy. Key activities include: broadcast, publication, or transmission of any content in connection with the 4th Winter Youth Olympic Games Gangwon 2024 and their legacy, in any format and through any media or technology (whether now existing or created in the future), operated by Gangwon 2024 and/or the IOC, or by authorised media rights holders and other media organisations; presentation of Participants and provision of related services to the media covering the 4th Winter Youth Olympic Games Gangwon 2024;
- h. performing legal obligations. Key activities include: disclosing Personal Data to authorities on the basis of Gangwon 2024's and/or the IOC's good faith belief of being under a legal obligation to do so;
- i. communicating with Accredited Persons and informing them about the 4th Winter Youth Olympic Games Gangwon 2024 and activities of Gangwon 2024, the IOC and the Olympic Movement: *Key activities include: sending of communications via email or otherwise regarding 4th Winter Youth Olympic Games Gangwon 2024-related activities, answering queries from Accredited Persons, providing promotional or marketing communications.*

5. Categories of Personal Data Processed

- 5.1 Personal Data Processed by Gangwon 2024 and/or the IOC for the Authorised Purposes can be categorised as follows:
- a. biographical information such as family and given names, nationality, date of birth, gender, photograph;
- b. contact and travel details such as postal address, email addresses, phone number, public social media accounts, booking number, arrival and departure information;
- c. information related to the participation in the 4th Winter Youth Olympic Games Gangwon 2024 such as accreditation number, sport(s) and discipline(s), team, performances, results, function, National Olympic Committee, International Federation, registration number;
- d. other relevant information necessary for or in relation to the protection of the life, body or property of a person, the security, the preparation, promotion, presentation and operation of the 4th Winter Youth Olympic Games Gangwon 2024, the prevention of the manipulation of competitions or the conduct of the anti-doping programme (whereabouts, etc.).
- 5.2 Sensitive Personal Data Processed by Gangwon 2024 and/or the IOC for the Authorised Purposes can be

categorised as follows:

- a. physiological information, such as height, weight, biometrics, blood and urine samples, illnesses, injuries, infectious diseases and access control systems; and
- b. health data related to the health status of a person including medical data (doctor referrals and prescriptions, medical examination reports, laboratory tests, radiographs, etc.).
- 5.3 Unique Identification Data Processed by Gangwon 2024 and/or the IOC for the Authorised Purposes can be categorised as follows:
- a. passport/identity document number, identity document details

6. Personal Data recipients

Gangwon 2024 and the IOC may share Personal Data including but not limited to those categorised in Section 5.2 and 5.3 above between them and with the IOC's Affiliates and other service providers or third parties acting on their behalf, for carrying out the Authorised Purposes. Moreover, the following recipients may have access to such Personal Data where required by their respective operations, and responsibilities in connection with the 4th Winter Youth Olympic Games Gangwon 2024 and Gangwon 2024 and the IOC shall be authorised to share such Personal Data with these recipients, where necessary for the Authorised Purposes until the respective Authorised Purposes for accessing such Personal Data are fulfilled:

- a. International Federations, who are responsible for the organisation of their sport at the 4th Winter Youth Olympic Games Gangwon 2024. The Personal Data shared may include some of the Personal Data listed in Sections 5.1, 5.2 and 5.3 above:
- b. National Olympic Committees, who select and send Participants to the 4th Winter Youth Olympic Games Gangwon 2024. The Personal Data shared may include some of the Personal Data listed in Sections 5.1, 5.2 and 5.3 above;
- c. competent authorities, including any national authorities, who are responsible for ensuring the safety and security of the 4th Winter Youth Olympic Games Gangwon 2024, the admission and stay of Accredited Persons in the host country and more generally accomplish their mission to support the preparation, promotion and operation of the Games in accordance with applicable laws. The Personal Data shared may include some of the Personal Data listed in Sections 5.1, 5.2 and 5.3 above;
- d. the Court of Arbitration for Sport ("**CAS**") headquartered in Switzerland, whom has been granted authority to settle disputes in connection with the 4th Winter Youth Olympic Games Gangwon 2024. The Personal Data shared may include some of the Personal Data listed in Sections 5.1, 5.2 and 5.3 above;
- e. International Testing Agency ("ITA") headquartered in Switzerland, whom the IOC has entrusted with certain tasks related to the implementation of the anti-doping programme in relation to the 4th Winter Youth Olympic Games Gangwon 2024. The Personal Data shared may include some of the Personal Data listed in Sections 5.1, 5.2 and 5.3 above:
- f. the World Anti-Doping Agency ("WADA") headquartered in Canada and other Anti-Doping Organisations who fulfil their mission to fight against doping in accordance with the World Anti-Doping Code. The Personal Data shared may include some of the Personal Data listed in Sections 5.1, 5.2 and 5.3 above;
- g. insurance providers who may provide insurance services to Accredited Persons. The Personal Data shared may include some of the Personal Data listed in Sections 5.1 and 5.3 above;
- h. healthcare and medical service providers who may provide treatment to Accredited Persons during their stay at the 4th Winter Youth Olympic Games Gangwon 2024. The Personal Data shared may include some of the Personal Data listed in Sections 5.1 and 5.2 above;
- i. media rights holders, broadcasters and other media organisations, who report on the 4th Winter Youth Olympic Games Gangwon 2024 and inform the general public. The Personal Data shared may include some of the Personal Data listed in Section 5.1 as well as height and weight;
- j. Olympic Marketing Partners (TOP Partners), Gangwon 2024's domestic sponsors and other commercial partners, who provide services in connection with the 4th Winter Youth Olympic Games Gangwon 2024 and promote their partnership with the Olympic Movement. The Personal Data shared may include some of the Personal Data listed in Sections 5.1 and 5.3 above as well as height and weight;
- k. Travel and accommodation service providers, who provide services to Accredited Persons. The Personal Data shared may include some of the Personal Data listed in Sections 5.1 and 5.3 above;
- I. any organisation designated by Gangwon 2024 and/or the IOC as a transferee of legacy and knowledge of the 4th Winter Youth Olympic Games Gangwon 2024 for the benefit of the Olympic Movement or any future sports or cultural events. The Personal Data shared may include some of the Personal Data listed in Section 5.1 above.

Where the above-mentioned recipients consider such measure necessary for the Authorised Purposes, they may combine or supplement any Personal Data of Accredited Persons received from Gangwon 2024 and the IOC with any other information in their possession. Accredited Persons are invited to consult the websites or other official information sources made available by the above-mentioned recipients for additional information regarding their respective operations and activities and related Processing of Personal Data. Personal Data will normally be Processed in a confidential manner. Some of the Personal Data, such as some biographical information and information related to the participation of Participants in the competitions of the 4th Winter Youth Olympic Games

Gangwon 2024 or related to breaches of rules applicable to Accredited Persons may be publicly disclosed.

7. Grounds for Processing Personal Data

Processing of Personal Data of Accredited Persons is based on the following grounds:

- a. the contractual necessity in view of allowing and facilitating the Participants' participation in the 4th Winter Youth Olympic Games Gangwon 2024 and more generally the performance by Accredited Persons of their respective operations and responsibilities in connection with the 4th Winter Youth Olympic Games Gangwon 2024, (cf. Section 4 paragraphs a, b, f and i);
- b. the substantial public interest to guarantee the safety and security at the 4th Winter Youth Olympic Games Gangwon 2024, to protect the health and wellbeing of Accredited Persons, carry out anti-doping activities, protect clean athletes, prevent manipulations of competitions, inform the general public and promote the 4th Winter Youth Olympic Games Gangwon 2024 (cf. Section 4 paragraphs c, d, e, f and g);
- c. the legitimate interests of Gangwon 2024 and the IOC to ensure that Accredited Persons respect their covenant to comply with the provisions applicable to Accredited Persons (including the Olympic Charter and the IOC Code of Ethics, as well as for Participants the IOC Anti-Doping Rules applicable at the occasion of the 4th Winter Youth Olympic Games Gangwon 2024, the World Anti-Doping Code and the rules referred to in section 1 of the Conditions of Participation), as well as to promote the 4th Winter Youth Olympic Games Gangwon 2024 and their legacy (cf. Section 4 paragraphs e and g);
- d. applicable legal provisions authorising the Processing of Personal Data for the Authorised Purposes, as well as compliance with a legal obligation of Gangwon 2024, the IOC or other recipients listed under Section 6 (cf. Section 4 in particular, without limitation, its paragraphs e and h);
- e. protection of the vital interests of Participants or of another natural person when providing healthcare services (cf. Section 4 paragraph d); and
- f. Accredited Persons' consent, where expressly granted (cf. Section 4 paragraph i where recipient's consent is required by applicable law).

8. Retention period of Personal Data

As a general rule, the Processing of Personal Data of Accredited Persons described in this Information Notice will cease after a period of four years following the end of the 4th Winter Youth Olympic Games Gangwon 2024. Personal Data of Accredited Persons may be kept for a longer period of time where necessary to fulfil the Authorised Purposes including, without limitation, information deemed of historical interest (such as sports results, key biographical information) which may be kept as long as necessary for the purposes listed in Section 4 paragraphs f and g and information related to the compliance of activities occurring at the 4th Winter Youth Olympic Games Gangwon 2024 with the Olympic Charter and other rules applicable to Accredited Persons processed for the purposes listed in Section 4 paragraphs e and h. Retention periods applicable to anti-doping activities are specified in the Annex A of the International Standard on Protection of Privacy and Personal Information, forming part of the World Anti-Doping Code, which provides that Personal Data of Participants may be retained over time by WADA, the IOC and the ITA for a period up to 10 years or indefinitely.

9. Security of Personal Data

Gangwon 2024 and the IOC will use technical and organisational measures to protect Personal Data against the risks of damage, destruction, loss or unauthorised access, in accordance with applicable laws.

10. International Transfer

Gangwon 2024 and the IOC will Process Accredited Persons' Personal Data mainly in the Republic of Korea where the 4th Winter Youth Olympic Games Gangwon 2024 take place, and in Switzerland where the IOC headquarters are located. However, they shall be entitled to make Accredited Persons' Personal Data available to entities listed in Section 6 located in other countries, including outside the Republic of Korea and the EU/EEA. In such case, Gangwon 2024 and the IOC shall take measures required by applicable data protection laws to ensure that Personal Data of Accredited Persons continue to benefit from an adequate level of protection.

11. Rights of Accredited Persons

Gangwon 2024 and the IOC have designated a person in charge of receiving complaints or questions in relation to the Processing of Accredited Persons Personal Data, that can be contacted at the following addresses in order to exercise their right to request access, rectification, erasure, restriction of processing, objection to the processing or to the adoption of automated decisions and, be it the case, data portability, as well as the remaining privacy rights and digital rights:
